

**General terms and conditions for rental of camping barrels** (valid from 01.11.2017)

**§ 1 conclusion of the contract**

The lease is concluded upon payment of the deposit to the due date stated on the booking confirmation. He is adapted to the actually present conditions upon arrival. Subsequently, minimum booking times are not trimmed. For non-payment of the deposit, the reservation goes out on the day after the maturity date of the deposit, without being a further information. Transfers in an equivalent barrel of camping are permitted on the part of the lessor for organizational and technical reasons. If nothing else is agreed, the reservation on the day of arrival expires 20:00. The landlord decides on the acceptance of bookings and forward bookings for groups, this may not be required by guests. Guests under 18 years of age may use the camping drums accompanied by legal guardian, unwittingly confirmed bookings do not apply.

**§ 2 prices and payment**

The amount of the rent and possible discounts are the valid price list.

Of the rent payment on arrival cash or ec card. Payments will be charged in.

Surcharges price list apply at the time of the 09.05.2018 to 13.05.2018 and from 18.05.2018 to 21.05.2018.

**§ 3 arrival and departure**

Arrival on the day of arrival from 15:00 to 19:00 with extra charge (only by appointment)

Departure on the day of departure from 8:00 to 10:00 with extra charge (only by appointment)

**§ 4 parking of cars**

CAR / Krad are to turn off on the designated location. Driving ban from 23:00 to 7:00.

**§ 5 withdrawal / cancellation / early departure**

The cancellation of the contract can be done at any time, for the avoidance of doubt this is signed only by the lessee in writing possible. The cancellation date is the entrance of the cancellation. A processing fee in the amount of €16.00 is calculated for each cancellation.

Additional costs for short-term cancellations:

-from 28 days prior to arrival cancellation costs in the amount of the deposit

-from 14 days before arrival 50% of the rental price

-from 7 days prior to arrival date 75% of the rental price

To prevent financial damage, we recommend concluding a travel cancellation insurance policy with an insurer of your choice. Early departure, no entitlement to repayment or remission of the amount.

Disturbance during the stay because of force majeure or caused by third parties such as bad weather does not lead to the reduction of the rent.

**§ 6 availability of the camping barrel / pets**

The occupancy of the camping barrel maximum is the number of people specified in the rental agreement and exclusively by the persons listed in the application, with 2 people. While children of all ages in the number of persons are included. The benefits of the camping barrel people reported not in the camping barrel is not allowed. Pets are not allowed. Bedding is available at no extra charge.

**§ 7 special terms and conditions / Disclaimer**

**Smoking is prohibited in the camping barrel.** The renter is liable for loss or damage arising to the rent object (also by other passengers and visitors of the lessee). The lessor shall be liable not for damage to inventory installed with the tenant and the parked car and damages caused by third, greater violence and wild animals, as well as accidents because of the found natural terrain. The sockets are with 16 amp. hedged.

**§ 8 complaints**

Claims to the leased object must be reported up to two hours after arrival at the reception. Like we carry out short-term improvements identified defects. Damages incurred during the rental period are to notify the landlord immediately. The Elimination of damage is agreed. Complaints cannot be considered upon departure.

**§ 9 area and campsite regulations**

The area and campsite regulations is an integral part of the contract and is recognized by the renter for all passengers and visitors with signature under the registration. Reference of tenants from the recreational park and the cottage due to severe violation of the Treaty or the rental fee is not refundable the area and campsite regulations.
